  4. Size of Space: 10' x 10'.
  5. **No merchandise that portrays Rock the Dock Fishing Tournament is allowed.**
  6. **The park can be very windy so please make sure you secure your tent with tie downs / weights.**
  7. Event Hours: Sat, May 3, 1 pm – 6 pm (or until weigh in is over) Sun, May 4, 11am – 6 pm. Vendors are obligated to remain open during the event hours. All booths must be removed from the area on Sunday evening.
  8. Vendors may start setting up on Saturday at 10 a.m. and set-up must be completed and all vehicles removed from the area by 12:30 pm. Set up on Sunday will begin at 9 am and vehicles removed by 10:30 am. Vehicles will not be allowed to return until after the event closes.
  9. You are responsible for your own tent, tables and chairs.
  10. There is limited power and no water. Please provide your own generator if you need power.
  11. Items left over night will be at your own risk.
