- Space assignment is the right of the event committee. Booth spaces are 10 X 10 each
- All breweries are responsible for their own display, tablecloth and tent. Tents must have guy lines or must be securely weighted down.
- Event Hours: Saturday, March 22, 2025 from 12 pm – 4 pm. We ask that brewery reps remain in the park during the event hours.
- Set-up can start at 7:00 am on Saturday morning and must be completed and all vehicles removed from the park by 11:00 am. Vehicles will not be allowed to return until after the event ends.
- Items left over night will be at your own risk.
- Please place all trash in a designated trash or recycling container.
- For security and safety purposes, no one under the age of 21 years old (including children, toddlers and babies) will be allowed in the Beer Garden area. Please bring ID for age verification.
